Thank You for 40 Great Years

As we reflect back on the last 40 years, we would like to extend a heartfelt thanks to all of our wonderful clients, committed community partners, legal colleagues, supportive families, devoted staff and the City of Seminole. It is worth noting that our story started before 1976. Born and raised in Georgia, Dennis R. DeLoach Jr. graduated from the University of Georgia in 1960 and Stetson University College of Law in 1963. A year later he joined the law firm of Fisher & Sauls, P.A. in St. Petersburg. In 1965, Dennis transferred to Fisher & Sauls' Seminole

1976




Happy 40th Anniversary
